Standard Protocols	For all risk levels: stay home if you are sick, maintain physical distance of 6 feet from others (outside of immediate family) whenever possible, wear face coverings in public when physical distancing is not possible, wash hands frequently for at least 20 seconds or use hand sanitizer, maintain increased awareness, cleaning, and other protocols as established. Gatherings are to implement physical distancing, use of face coverings by staff and participants, increased sanitization measures, and increased personal hygiene measures (handwashing/hand sanitizing). All individuals carefully monitor their health.				

*Students in isolation: The number of students with a confirmed case of COVID-19 who live in campus housing and are restricted from leaving their campus residence.

**Impact of faculty/staff cases: Ranges from no significant impact on classes (regardless of modality) to a significant impact caused by the number of faculty/staff confirmed COVID-19 cases resulting in reduction in or temporary suspension of classes or services.
