<ol> <li>I understand:         <ol> <li>A \$35.00 non-refundable registration fee per child is due annually.</li> <li>If my child is picked up late, past the center closing time or my contracted times, I understand an overtime charge of \$1.00 for each minute will be due and payable at the time of pick up.</li> <li>A \$30.00 unscheduled drop in fee is charged per child for non-contracted time. Payable at that time.</li> <li>Times may be adjusted within thirty (30) days of beginning date. Adjustments will not be accepted after 30 days.</li> <li>No allowances or reductions on tuition will be given for absences due to illness, vacation, or snow days.</li> <li>If my child becomes ill at the center, he/she will be isolated and I will be given one hour from the time the first attempt is made to contact me to have my child picked up. After one hour, the center will care for my child at the rate of \$10.00 per hour. This is also payable at the time of pick up.</li> </ol> </li> <li>Fees are due by the 1st of each month. If the fee is not paid by the 5th, a late fee of \$20.00 will be charged.</li> <li>A bimonthly payment plan of the 1st and 15th may be set up with the office.
